



EXTERNAL INTEGRATED SUMMATIVE ASSESSMENT (EISA) SCHEDULE FOR THE 2022/2023 FINANCIAL YEAR

1. Context

The Education, Training and Development Practices, Sector Education and Training Authority (**ETDP SETA**) is an approved Assessment Quality Partner (AQP) of the Quality Council for Trades and Occupations (**QCTO**) and is delegated among others, to oversee and manage assessment functions for occupational qualifications, which fall within the Education, Training and Development sector. This involves planning for, management and coordination of External Integrated Summative Assessment (EISA) sessions for occupational qualifications allocated to the ETDP SETA by the QCTO.

In its endeavours to discharge the delegated AQP functions, the ETDP SETA hereby introduces an EISA schedule, which give notice of the dates for the conduct of the EISA sessions during the period **01 April 2022 – 31 March 2023**. Further to that, this schedule provides guidance to the Skills Development Providers (SDPs) on the platform that must be used for the submission of EISA Application Forms.

2. Approach and Process

During the period 01 April 2022 – 31 March 2023, the ETDP SETA will conduct four EISA sessions for occupational qualifications allocated to it by the QCTO. External Integrated Summative Assessment sessions shall be conducted through QCTO accredited Assessment Centres. Publication of the External Integrated Summative Assessment schedule for the period mentioned above, will assist the Skills Development Providers, Assessment Centres, Learners and Employers to be conversant with the important dates, location of assessment centre and occupational qualifications that fall with the scope of the ETDP SETA.

Furthermore, the approach directs the Skills Development Providers to the process and instrument to be used to apply, on behalf of their candidates' seats in an External Integrated Summative Assessment session. Accordingly, Skills Development Providers are directed to complete the **External Integrated Summative Assessment Application Form** available from <https://www.etdpseta.org.za/education/aqp-documents> . 
